

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0356

Affirmed
Late Request for Hearing Allowed
Disqualification

PROCEDURAL HISTORY: On December 3, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective October 4, 2020 (decision # 103851). On December 23, 2020, decision # 103851 became final without claimant having filed a request for hearing. On December 29, 2020, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 6, 2021 issued Order No. 21-UI-158717, dismissing the request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 20, 2021. On January 13, 2021, claimant filed a timely response to the appellant questionnaire. On February 10, 2021, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 21-UI-158717 was vacated, and that a hearing would be scheduled to determine if claimant's late request for hearing on decision # 103851 should be allowed and, if so, the merits of that decision. On April 5, 2021, ALJ S. Lee conducted a hearing, and on April 15, 2021 issued Order No. 21-UI-164958, allowing claimant's late request for hearing and affirming decision # 103851. On May 3, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-164958 is affirmed.
