EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0366

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 30, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$4,500 in Federal Pandemic Unemployment Compensation benefits that claimant was required to repay to the Department (decision # 73438).¹ On December 21, 2020, decision # 73438 became final without claimant having filed a request for hearing. On March 12, 2021, claimant filed a late request for hearing on decision # 73438. ALJ Kangas considered claimant's request, and on April 14, 2021 issued Order No. 21-UI-164749, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 28, 2021. On May 4, 2021, Order No. 21-UI-164749 became final without claimant having filed an appellant questionnaire response with the Office of Administrative Hearings (OAH) or an application for review with the Employment Appeals Board (EAB). On May 5, 2021, claimant filed both a late application for review and a late appellant questionnaire response with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

FINDING OF FACT: (1) Order No. 21-UI-164749, mailed to claimant on April 14, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164749 at 2. Order No. 21-UI-164749 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 4, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-164749 is dismissed.

¹ The administrative decision also concluded that claimant had been *underpaid* \$6,645 in Pandemic Unemployment Assistance (PUA) benefits, and that, between the underpaid PUA benefits and the overpaid FPUC benefits, the Department owed claimant \$2,145. Exhibit 1 at 1, 3.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164749 was due by May 4, 2021. Because claimant did not file their application for review until May 5, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 5, 2021 is dismissed. Order No. 21-UI-164749 remains undisturbed.
