EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0368

Reversed No Disqualification

PROCEDURAL HISTORY: On March 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective August 23, 2020 (decision #74836). Claimant filed a timely request for hearing. On April 26, 2021, ALJ Murdock conducted a hearing, and on April 27, 2021 issued Order No. 21-UI-165636, affirming decision #74836. On May 6, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of new information contained within claimant's written argument, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. This additional evidence is necessary to complete the record. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Oswego Lake Country Club employed claimant as a server and bartender from July 29, 2020 until August 23, 2020.

(2) In early August 2020, claimant was offered a job performing similar work at Red Star Tavern, which was contained within a hotel. Claimant had previously worked for Red Star Tavern for several years until she was temporarily laid off in March 2020 due to the COVID-19 pandemic. When Red Star Tavern made the offer to claimant, they informed her that they had booked a "huge filming crew and production team to rent out the whole hotel and restaurant to do a 'Covid bubble' while filming," that they "would be in house for a few months," and that they intended to book similar productions in the future. EAB Exhibit 1 at 3.

- (3) At Oswego Lake Country Club, claimant worked about 30 hours per week and earned \$18.00 per hour, but only occasionally earned tips. When claimant had worked for Red Star Tavern, she worked about 25 to 30 hours per week and earned \$13.25 per hour plus regularly earned tips. Due to the tips she earned at Red Star Tavern, claimant earned "significantly less" at Oswego Lake Country Club than she earned at Red Star Tavern before her layoff due to COVID-19. EAB Exhibit 1 at 2.
- (4) On August 9, 2020, claimant gave Oswego Lake Country Club two weeks' notice that she was quitting to accept the job with Red Star Tavern. Claimant's last day working for Oswego Lake Country Club was August 23, 2020, and she began working for Red Star Tavern on August 24, 2020.

CONCLUSIONS AND REASONS: Claimant voluntarily quit work with good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless they prove, by a preponderance of the evidence, that they had good cause for leaving work when they did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause . . is such that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would leave work." OAR 471-030-0038(4) (September 22, 2020). "[T]he reason must be of such gravity that the individual has no reasonable alternative but to leave work." OAR 471-030-0038(4). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for their employer for an additional period of time.

A claimant who leaves work to accept an offer of other work "has left work with good cause only if the offer is definite and the work is to begin in the shortest length of time as can be deemed reasonable under the individual circumstances. Furthermore, the offered work must reasonably be expected to continue, and must pay [either] an amount equal to or in excess of the weekly benefit amount; or an amount greater than the work left." OAR 471-030-0038(5)(a).

Claimant voluntarily quit working for Oswego Lake Country Club in order to accept other work with her former employer Red Star Tavern. The order under review concluded that "the other work did not pay more than the work [claimant] left or more than her weekly benefit amount" because "gratuities are variable [and therefore] cannot be considered in determining whether the work paid more than the work left or the weekly benefit amount." Order No. 21-UI-165636 at 2. The record does not support this conclusion. The record shows that, based on her prior experience, claimant reasonably believed that with tips, she would earn more at Red Star Tavern than she earned at Oswego Lake Country Club. Further, the record shows that, despite working fewer hours and earning a lower hourly wage, claimant still earned more at Red Star Tavern than at Oswego Lake Country Club because of the tips she earned, showing that tips at Red Star Tavern constituted a substantial portion of her overall pay. In light of that evidence, the conclusion that tips cannot be considered in the calculation simply because they are "variable" does not pass substantial reason. Therefore, the record shows that the offer of other work paid more than the work claimant left.

The record also shows that the offer of work was definite, because there was no indication that the offered work was contingent upon anything. Although the August 2020 influx of filming crew guests was temporary, Red Star Tavern told claimant it intended to continue booking similar filming crews in the future, and there was no indication at the time the work was offered that it was intended to be

temporary or for a limited duration. Therefore, the work was reasonably expected to continue at the time it was offered. Further, because claimant began working at Red Star Tavern the day after her last day at Oswego Lake Country Club, the job started in the shortest length of time as can be deemed reasonable.

For the above reasons, claimant voluntarily quit work with good cause, and is not disqualified from receiving unemployment insurance benefits based on this work separation.

DECISION: Order No. 21-UI-165636 is set aside, as outlined above.
