EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0377

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective April 26, 2020 (decision # 181143). Claimant filed a timely request for hearing. On April 7, 2021, ALJ Amesbury conducted a hearing, and on April 9, 2021 issued Order No. 21-UI-164505, affirming decision # 181143. On April 29, 2021, Order No. 21-UI-164505 became final without the an application for review having been filed with the Employment Appeals Board (EAB). On May 10, 2021, the employer filed a late application for review of Order No. 21-UI-164505 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-164505, mailed to the employer on April 9, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164505 at 3. Order No. 21-UI-164505 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 29, 2021 to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 21-UI-164505 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

¹ On April 13, 2021, the Department issued an administrative decision stating that the Department had no jurisdiction to issue decision # 181143 because claimant had sufficient earnings to preclude the disqualification and that decision # 181143 was of no force and effect and was cancelled. The April 13, 2021 administrative decision also stated that since the Department had cancelled decision # 181143, claimant's appeal before the Office of Administrative Hearings (OAH), which resulted in issuance of Order No. 21-UI-164505, was void by operation of law. This decision dismisses the employer's application for review of Order No. 21-UI-164505 on the independent basis that the employer filed the application for review late. This decision does not address whether the April 13, 2021 administrative decision rendered Order No. 21-UI-164505 void.

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164505 was due April 29, 2021. Because the employer did not file their application for review until May 10, 2021, the application for review was late. The employer's application for review did not include a written statement describing the circumstances that prevented the employer from filing the application for review by the May 10, 2021 deadline. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed May 10, 2021 is dismissed. Order No. 21-UI-164505 remains undisturbed.
