# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0380

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 16, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 5, 2020 (decision # 115508). On December 7, 2020, decision # 115508 became final without claimant having filed a request for hearing. On March 11, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 13, 2021 issued Order No. 21-UI-164678, dismissing claimant's request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 27, 2021. On April 30, 2021, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH), and a timely application for review of Order No. 21-UI-164678 with the Employment Appeals Board (EAB). On May 17, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, OAH would not consider it or issue another order, and that Order No. 21-UI-164678 remained in effect. This matter is before EAB based upon claimant's timely application for review of Order No. 21-UI-164678.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

The parties may offer new information, such as information that shows whether claimant had good cause for filing a late request for hearing and whether claimant filed their late request for hearing within a reasonable time, into evidence at the remand hearing. At that time, it will be determined if the new information will be admitted into the record. The parties must follow the instructions on the notice of the remand hearing regarding documents they wish to have considered at the hearing. These instructions will direct the parties to provide copies of such documents to the ALJ and the other parties in advance of the hearing at their addresses as shown on the certificate of mailing for the notice of hearing.

**CONCLUSIONS AND REASONS:** Order No. 21-UI-164678 is reversed and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed, and if so, the merits of decision # 115508.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on decision #115508 was December 7, 2020. Claimant filed their request for hearing on March 11, 2021. Therefore, the request for hearing was late.

However, the record under review indicates that claimant may have had good cause to file their request for hearing late because claimant did not receive decision #115508 in the mail. In their response to the appellant questionnaire, claimant stated that "I did not receive an administrative decision in the mail, I had to call and finally after a few weeks got in contact with someone at the unemployment office and they requested this hearing." EAB Exhibit 1 at 1.

The fact that claimant did not receive the decision in the mail may have constituted a factor beyond claimant's reasonable control that prevented claimant from filing a request for hearing by the December 7, 2020 deadline. However, the record is insufficient to determine when claimant learned of the existence of decision #115508 and whether or not claimant gained that knowledge with sufficient time to file a request for hearing by the December 7, 2020 deadline. Further, to the extent that claimant's failure to receive decision #115508 in the mail constituted a factor beyond claimant's reasonable control, the record is insufficient to determine whether claimant's March 11, 2021 late request for hearing was filed within a reasonable time, that is, within seven days after the circumstances that prevented a timely filing ceased to exist.

Because further development of the record is necessary for a determination of whether claimant filed a late request for hearing that should be allowed, this matter is remanded for a hearing and order. If the ALJ concludes that claimant filed a request for hearing that should be allowed, the ALJ must then develop a record on the merits of decision # 115508.

**DECISION:** Order No. 21-UI-164678 is set aside, and this matter remanded for further proceedings consistent with this order.
