

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0395

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On January 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective November 29, 2020 (decision # 85540). On January 25, 2021, decision # 85540 became final without claimant having filed a request for hearing. On January 29, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 22, 2021 issued Order No. 21-UI-161378, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 8, 2021. On March 4, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on May 10, 2021 issued Order No. 21-UI-166485, cancelling Order No. 21-UI-161378 and re-dismissing claimant's hearing request on decision # 85540 as late without a showing of good cause. On May 15, 2021, claimant filed an application for review of Order No. 21-UI-166485 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that the additional evidence was relevant and material to EAB's determination because it did not describe reasons that claimant filed a late request for hearing. Under OAR 471-041-0090(1)(B)(a) (May 13, 2019), EAB did not consider additional information contained in claimant's written argument when reaching this decision. See OAR 471-040-0041(4).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-166485 is affirmed.
