EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0441

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 9, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On March 1, 2021, the February 9, 2021 administrative decision became final without claimant having filed a request for hearing. On March 5, 2021 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 4, 2021 issued Order No. 21-UI-166103 dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 18, 2021. On May 24, 2021, Order No. 21-UI-166103 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 21-UI-166103 with the Employment Appeals Board (EAB). On May 28, 2021 claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-166103 with EAB. On June 2, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's May 28, 2021 late application for review of Order No. 21-UI-166103.

FINDING OF FACT: (1) Order No. 21-UI-166103, mailed to claimant on May 4, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-166103 at 2. Order No. 21-UI-166103 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 24, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-166103 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-166103 was due on May 24, 2021. Because claimant did not file their application for review until May 28, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, which therefore is dismissed.

DECISION: The application for review filed May 28, 2021 is dismissed. Order No. 21-UI-166103 remains undisturbed.
