

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0443

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective March 29, 2020 (decision # 124610). On December 29, 2020, decision # 124610 became final without claimant having filed a request for hearing. On January 29, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 18, 2021 issued Order No. 21-UI-161162, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 4, 2021. On February 24, 2021, claimant filed a timely response to the appellant questionnaire. On April 5, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-161162 was vacated and that a hearing would be scheduled. On April 28, 2021, OAH mailed notice of a hearing scheduled for May 12, 2021 to consider claimant's late request for hearing, and if allowed, the merits of decision # 124610. On May 12, 2021, ALJ Janzen conducted a hearing, and on May 13, 2021 issued Order No. 21-UI-166701, re-dismissing claimant's late request for hearing as without good cause and leaving decision # 124610 undisturbed. On May 18, 2021, claimant filed a timely application for review of Order No. 21-UI-166701 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-166701 is affirmed.
