

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0449

Dismissed
Application for Review Withdrawn

PROCEDURAL HISTORY: On February 1, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant not for misconduct and that claimant was not disqualified from receiving unemployment insurance benefits (decision # 122412). The employer filed a timely request for hearing. On May 20, 2021, ALJ Micheletti conducted a hearing, and on May 28, 2021, issued Order No. 21-UI-167755, affirming decision # 122412. On June 8, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: (1) On June 9, 2021, the employer submitted a written request to withdraw their application for review of Order No. 21-UI-167755.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On June 9, 2021, EAB received a letter in which the employer withdrew the application for review of Order No. 21-UI-167755. EAB had not yet issued a decision. Under OAR 471-041-0098, the employer's request to withdraw is allowed.

DECISION: The application for review filed June 8, 2021 is dismissed. Order No. 21-UI-167755 remains undisturbed.
