EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0451

Orders No. 21-UI-167218, 21-UI-167217 and 21-UI-167195 Affirmed Disqualification (Weeks 25-20 through 36-20) Benefit Reduction (Weeks 12-20 through 24-20 and 37-20 through 19-21)

PROCEDURAL HISTORY: On April 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant's retirement pay reduced her weekly benefit amount for each of the weeks including March 15, 2020 through June 13, 2020 (weeks 12-20 through 24-20) (decision # 110036). On April 13, 2021, the Department served notice of a second administrative decision concluding that claimant was receiving retirement pay that was more than or equal to her weekly benefit amount, disqualifying claimant from receiving unemployment insurance benefits for each of the weeks including June 14, 2020 through September 5, 2020 (weeks 25-20 through 36-20) (decision # 112022). On April 13, 2021, the Department served notice of a third administrative decision concluding that claimant's retirement pay reduced her weekly benefit amount for each of the weeks including September 6, 2020 through April 10, 2021 (weeks 37-20 through 14-21) and until the reason for the reduction had ended (decision #113804). Claimant filed timely requests for hearing on decisions #110036, #112022, and #113804. On May 18, 2021, ALJ S. Lee conducted a consolidated hearing on all three administrative decisions. On May 20, 2021, ALJ S. Lee issued Order No. 21-UI-167218 affirming decision # 110036; Order No. 21-UI-167217 affirming decision #112022; and Order No. 21-UI-167195 modifying decision #113804 by concluding that claimant's retirement pay reduced her weekly benefit amount for each of the weeks including September 6, 2020 through May 15, 2021 (weeks 37-20 through 19-21). On June 4, 2021, claimant filed applications for review of Orders No. 21-UI-167218, 21-UI-167217 and 21-UI-167195 with the Employment Appeals Board.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-167218, 21-UI-167217 and 21-UI-167195. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-0451, 2021-EAB-0452 and 2021-EAB-0450).

FINDINGS OF FACT: (1) In 2010, claimant retired and began receiving retirement benefits from the Oregon Public Employees' Retirement System (PERS) based on her previous work with PERS employers. Claimant's weekly retirement pay amount was \$272.¹

(2) After retiring, claimant worked for several employers, including both educational and noneducational employers. From October 2018 through September 2019, several of claimant's educational employers contributed to PERS by contributing to the accounts of full-time employees who were eligible for employee benefits, but they did not contribute to claimant's individual PERS account because claimant was employed with them as a part-time employee who did not receive employee benefits.

(3) On March 19, 2020, claimant filed an initial claim for unemployment insurance benefits. The Department determined that claimant had a valid claim and that claimant's base year was October 1, 2018 through September 30, 2019. The Department also determined that claimant's base year employers included both educational and non-educational employers and that claimant's weekly benefit amount based on wages from those employers was \$317. The Department also determined that for the weeks including June 14, 2020 through September 5, 2020 (weeks 25-20 through 36-20), during the summer recess period of one of claimant's educational employers, claimant's monthly benefit amount was reduced to \$234 based only on the non-school portion of claimant's base year wages.

(4) Claimant filed weekly claims for benefits for each of the weeks including March 15, 2020 through May 15, 2021 (weeks 12-20 through 19-21), the weeks at issue. The Department paid claimant benefits for each of those weeks.

CONCLUSIONS AND REASONS: Claimant is disqualified from receiving benefits for the weeks including June 14, 2020 through September 5, 2020 (weeks 25-20 through 36-20) because she received retirement benefits that exceeded her weekly benefit amount for each of those weeks. Claimant's benefits are reduced for the weeks including March 15, 2020 through June 13, 2020, and September 6, 2020 through May 15, 2021 (weeks 12-20 through 24-20 and 37-20 through 19-21) by the amount of retirement pay she received during each of those weeks.

ORS 657.205(1) provides, "an individual is disqualified for benefits for any week with respect to which the individual is receiving, will receive, or has received a governmental or other pension, retirement or retired pay, annuity, or other similar periodic payment based on the previous work of the individual, if payment is received under a plan maintained or contributed to by a base year employer of the individual." If "the remuneration and payments, or the pro rata share thereof, in any week are less than the benefits which would otherwise be due . . . for such week, such individual is entitled to receive for such week, if otherwise eligible, benefits reduced by the amount of such remuneration and payments." ORS 657.205(5).

The record shows that for each week at issue, claimant received retirement pay of \$272 from PERS. The record also shows that several of claimant's base year employers contributed to PERS. For these reasons, under ORS 657.205(1), the Department correctly disqualified claimant from receiving benefits

¹ Claimant received monthly retirement payments from PERS in the amount of \$1,176.67. Claimant's monthly retirement payments were converted to a weekly retirement payment amount according to a formula set forth by OAR 471-030-0020 (January 11, 2018). Applying that formula yielded the weekly retirement payment amount of \$272.

for the weeks including June 14, 2020 through September 5, 2020 (weeks 25-20 through 36-20) because claimant's weekly retirement pay of \$272 exceeded her weekly benefit amount of \$234 for each of those weeks. Under ORS 657.205(5), the Department also correctly reduced claimant's weekly benefit amount of \$317 for each of the weeks including March 15, 2020 through June 13, 2020, and September 6, 2020 through May 15, 2021 (weeks 12-20 through 24-20 and 37-20 through 19-21) by her weekly retirement pay of \$272 because her weekly retirement pay was less than her weekly benefit amount.

Claimant argued at hearing that because none of her base year employers contributed to her individual PERS account, her weekly benefit amount should not have been eliminated or reduced. Transcript at 17-18, 20-22. Although none of claimant's base year employers contributed to her individual PERS account, under the plain language of ORS 657.205, it is immaterial that the employers did not contribute to claimant's individual PERS account because the employers contributed to PERS on any employee's behalf.

DECISION: Orders No. 21-UI-167218, 21-UI-167217 and 21-UI-167195 are affirmed.
