EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0461

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from December 6, 2020 through December 12, 2020, February 21, 2021 through March 6, 2021, and March 14, 2021 through March 20, 2021, and therefore was ineligible for benefits for those weeks and until the reason for the denial had ended (decision #130548). Claimant filed a timely request for hearing. On May 4, 2021, ALJ Murdock conducted a hearing, and on May 6, 2021 issued Order No. 21-UI-166325, affirming decision #130548. On May 26, 2021, Order No. 21-UI-166325 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 31, 2021, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 21-UI-166325, mailed to claimant on May 6, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-166325 at 3. Order No. 21-UI-166325 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 26, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-166325 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-166325 was due by May 26, 2021. Because claimant did not file their application for review until May 31, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 31, 2021 is dismissed. Order No. 21-UI-166325 remains undisturbed.
