EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0468

Late Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On January 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide the Department with information regarding their school employment by January 19, 2021 and was therefore disqualified from receiving unemployment insurance benefits from December 20, 2020 through January 2, 2021 (weeks 52-20 through 53-20) (decision # 115325). On February 9, 2021, decision # 115325 became final without claimant having filed a request for hearing. On April 20, 2021, claimant filed a late request for hearing on decision # 115325.

ALJ Kangas considered claimant's request, and on May 12, 2021 issued Order No. 21-UI-166654, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 26, 2021. On June 1, 2021, Order No. 21-UI-166654 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On June 2, 2021, claimant filed a late response to the appellant questionnaire and a late application for review with EAB. On June 10, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's June 2, 2021 application for review of Order No. 21-UI-166654.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On June 2, 2021, the appellant filed an application for review of Order No. 21-UI-166654 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than June 1, 2021. The appellant's application for review is therefore late, and dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is July 1, 2021, making the deadline July 21, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed June 2, 2021 is dismissed without prejudice. Order No. 21-UI-166654 remains undisturbed.
