EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0469

Affirmed Disqualification

PROCEDURAL HISTORY: On December 4, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was receiving retirement pay that was more than or equal to his weekly benefit amount, disqualifying claimant from receiving unemployment insurance benefits from June 28, 2020 through October 31, 2020 (weeks 27-20 through 44-20) and until the reason for the disqualification from benefits ended (decision # 95255). Claimant filed a timely request for hearing. On May 4, 2021, ALJ Logan conducted a hearing, and on May 11, 2021 issued Order No. 21-UI-166529, affirming decision # 95255. On May 25, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) In 2014, claimant began receiving retirement benefits from the Oregon Public Employees' Retirement System (PERS). Claimant's weekly retirement pay amount was \$654.49.¹

- (2) Thereafter, claimant worked for Oregon Health & Sciences University (OHSU). OHSU contributed to claimant's PERS retirement plan.
- (3) On July 2, 2020, claimant filed an initial claim for unemployment insurance benefits. The Department determined claimant's weekly benefit amount was \$475.00, and that OHSU was one of claimant's base year employers.
- (4) Claimant filed weekly claims for benefits for the weeks from June 28, 2020 through October 31, 2020 (weeks 27-20 through 44-20), the weeks at issue. The Department paid claimant benefits for each of the weeks at issue.

CONCLUSIONS AND REASONS: Claimant is disqualified from benefits because he received retirement benefits that exceeded his weekly benefit amount.

¹ Claimant received monthly retirement payments in the amount of \$2,836.14; the monthly payments are converted to a weekly retirement pay amount according to a formula set forth by OAR 471-030-0020 (January 11, 2018). Applying that formula yields the \$654.49 weekly retirement pay amount figure.

ORS 657.205(1) provides, "an individual is disqualified for benefits for any week with respect to which the individual is receiving, will receive, or has received a governmental or other pension, retirement or retired pay, annuity, or other similar periodic payment based on the previous work of the individual, if payment is received under a plan maintained or contributed to by a base year employer of the individual." If "the remuneration and payments, or the pro rata share thereof, in any week are less than the benefits which would otherwise be due . . . for such week, such individual is entitled to receive for such week, if otherwise eligible, benefits reduced by the amount of such remuneration and payments." ORS 657.205(5).

The record shows that claimant's weekly retirement pay amount during the weeks at issue was \$654.49, which is more than his weekly benefit amount of \$475.00. OHSU, one of claimant's base year employers, contributed to claimant's PERS retirement plan. Because claimant received PERS retirement benefits in an amount that exceeded his weekly benefit amount, and one of claimant's base year employers contributed to the retirement plan, claimant is disqualified from receiving unemployment insurance benefits pursuant to ORS 657.205.

DECISION: Order No. 21-UI-166529 is affirmed.
