EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0489

Late Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On September 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$5,688 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay the Department (decision # 114301). Claimant filed a timely request for hearing. On October 8, 2020, ALJ Scott conducted a hearing, and on October 13, 2020, issued Order No. 20-UI-155178, affirming decision # 114301. On November 2, 2020, Order No. 20-UI-155178 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 16, 2021, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 20-UI-155178, mailed to claimant on October 13, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-155178 at 3. Order No. 20-UI-155178 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 2, 2020 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-155178 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-155178 was due by November 2, 2020. Because claimant did not file their application for review until June 16, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed June 16, 2021 is dismissed. Order No. 20-UI-155178 remains undisturbed.
