EMPLOYMENT APPEALS BOARD DECISION **2021-EAB-0491**

Affirmed
Benefits Allowed in Part, Denied in Part

PROCEDURAL HISTORY: On April 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was ineligible for benefits for the weeks including September 13, 2020 through October 3, 2020 (weeks 38-20 through 40-20) because she was not able to work during those weeks (decision # 133329). Claimant filed a timely request for hearing. On May 28, 2021, ALJ Janzen conducted a hearing, and on June 1, 2021, issued Order No. 21-UI-167792, modifying decision # 133329 by concluding that claimant was ineligible for benefits for week 38-20 because she was not available for work, ineligible for benefits for week 39-20 because she was not able to work and eligible for benefits for week 40-20 because she was both able and available for work during that week. On June 15, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-167792 is affirmed.
