

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0492

Affirmed
Late Request for Hearing Allowed
Disqualification

PROCEDURAL HISTORY: On March 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 27, 2020 (decision # 151840). On April 12, 2021, decision # 151840 became final without claimant having filed a request for hearing. On April 13, 2021, claimant filed a late request for hearing. On May 25, 2021, ALJ Snyder conducted a hearing, and on May 28, 2021 issued Order No. 21-UI-167731, allowing claimant's late request for hearing and affirming decision # 151840. On June 17, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

In his written argument, claimant asserted that “. . . an examination ought to have been made [at hearing] to determine if claimant was constructively discharged due to the reduction of pay and hours after the start of the pandemic.” Claimant's Written Argument at 2. ORS 657.176 does not recognize the concept of a “constructive discharge.” Rather, a separation from work is deemed, for purposes of ORS Chapter 657, to be either a voluntary leaving or a discharge. If the employee could have continued to work for the same employer for an additional period of time, the work separation is a voluntary leaving. OAR 471-030-0038(2)(a) (September 22, 2020). If the employee is willing to continue to work for the same employer for an additional period of time but is not allowed to do so by the employer, the separation is a discharge. OAR 471-030-0038(2)(b).

Although the hearing record does suggest that the reduction of pay and hours was a motivating factor in claimant's decision to leave, the record is also clear that claimant chose to sever the employment relationship, and that the employer would have otherwise permitted claimant to continue working. For that reason, the record shows that claimant voluntarily left work. Rather than considering whether an individual's decision to quit means they have been "constructively discharged," ORS 657.176 and OAR 471-030-0038 instead contain provisions by which to determine whether the individual voluntarily quit with good cause, such that they would remain eligible for unemployment insurance benefits. For the reasons discussed in the order under review, the record shows that claimant voluntarily left work without good cause per OAR 471-030-0038(5)(b)(G).

Claimant also asserted in his written argument that "the notion that claimant left his employment for 'self-employment' casts claimant's situation in a false light" because he left work in order to "situate himself in a position so he could get off unemployment benefits wholly," and suggested that OAR 471-030-0038(5)(b)(G) is "inapplicable to the situation." Claimant's Written Argument at 4-5. To the extent that claimant is suggesting that the totality of the circumstances should be considered in determining whether he had good cause to quit, however, neither the record nor the applicable authority support such a position. Regardless of what motivated him to do so or what benefits he hoped to reap in doing so, the hearing record demonstrates that claimant voluntarily quit in order to purchase and operate his own restaurant. Therefore, claimant voluntarily quit in order to pursue self-employment. OAR 471-030-0038(5)(b)(G) contains no exceptions by which the totality of the circumstances may be considered. Because claimant voluntarily quit work in order to pursue self-employment, Oregon law dictates that he quit without good cause.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-167731 is affirmed.
