

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0494

Affirmed
Disqualification

PROCEDURAL HISTORY: On April 26, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective March 1, 2020 (decision # 114445). Claimant filed a timely request for hearing. On June 8, 2021, ALJ Monroe conducted a hearing, and on June 14, 2021 issued Order No. 21-UI-168681, affirming decision # 114445. On June 18, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: In support of their application for review, claimant submitted written arguments on July 2, 2021 and July 7, 2021. Claimant's arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's arguments to the extent they were based on the record.

EVIDENTIARY MATTER: After the June 8, 2021 hearing, the ALJ admitted claimant's request for hearing as Exhibit 2 into evidence and invited either party to submit a written objection to the Exhibit 2 admission within seven days of the ALJ's June 14, 2021 issuance of Order No. 21-UI-168681. Order No. 20-UI-168681 at 1. The record fails to demonstrate that either party filed a written objection. The ALJ failed, however, to mark claimant's request for hearing as "Exhibit 2." As a clerical matter, EAB identified the exhibit based on the ALJ's description of it, and marked it as "Exhibit 2."

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-168681 is affirmed.
