

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0495

Affirmed ~ Ineligible Weeks 15-20 through 31-20

PROCEDURAL HISTORY: On November 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able, available, and actively seeking work from April 5, 2020 through August 1, 2020 (weeks 15-20 through 31-20) and therefore ineligible to receive unemployment insurance benefits for those weeks (decision # 120315). Claimant filed a timely request for hearing. On June 1, 2021, ALJ Amesbury conducted a hearing, and on June 8, 2021 issued Order No. 21-UI-168340, affirming decision # 120315 by concluding that claimant was not available for work during weeks 15-20 through 31-20, and therefore ineligible for benefits for those weeks. On June 19, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-168340 is affirmed.
