

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0497**

*Affirmed*  
*No Disqualification*  
*Wage Credits Not Subject to Cancellation*

**PROCEDURAL HISTORY:** On January 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective August 23, 2020, and that all rights to benefits based upon wages claimant earned prior to August 28, 2020 were canceled effective August 23, 2020 (decision # 113537). On January 25, 2021, decision # 113537 became final without claimant having filed a request for hearing. On February 9, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 16, 2021 issued order No. 21-UI-162759, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 30, 2021.

On March 26, 2021, claimant filed a timely response to the appellant questionnaire. On May 18, 2021, the Office of Administrative Hearings (OAH) mailed a letter to claimant stating that Order No. 21-UI-162759 was vacated, and that a hearing would be scheduled to address whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 113537. On June 15, 2021 and June 16, 2021, ALJ Janzen conducted a hearing, and on June 17, 2021 issued Order No. 21-UI-168889, allowing claimant's late request for hearing and reversing decision # 113537 by concluding that the employer discharged claimant, but not for misconduct, that claimant was not disqualified from receiving benefits, and that his benefit rights based on his wage credits were not subject to cancellation. On June 21, 2021, the employer filed an application for review of Order No. 21-UI-168889 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-168889 is affirmed.
