# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0499

#### Late Applications for Review Dismissed

**PROCEDURAL HISTORY:** On March 25, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective December 8, 2019 (decision # 70117). On April 14, 2020, decision # 70117 became final without claimant having filed a request for hearing. On August 21, 2020, the Department served notice of an administrative decision, based in part on decision # 70117, assessing an overpayment of \$1,872 in regular unemployment insurance benefits that claimant was required to repay to the Department (decision # 92935). On September 10, 2020, decision # 92935 became final without claimant having filed a request for hearing. On April 19, 2021, claimant filed late requests for hearing on decisions # 70117 and # 92935.

On May 12, 2021, ALJ Kangas issued Order No. 21-UI-166634, dismissing claimant's request for hearing on decision # 70117 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 26, 2021. Also on May 12, 2021, ALJ Kangas issued Order No. 21-UI-166637, dismissing claimant's request for hearing on decision # 92935 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 26, 2021. On June 1, 2021, Orders No. 21-UI-166634 and 21-UI-166637 became final without claimant having responded to the appellant questionnaires or filing applications for review of either order.

On June 2, 2021 claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-166634 with the Employment Appeals Board (EAB). Also on June 2, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-166637 with EAB. On June 14, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding claimant's late request for hearing on decision # 70117 because the questionnaire response was late. Also on June 14, 2021, ALJ Kangas mailed a letter stating that OAH would not consider claimant's questionnaire response or issue another order regarding claimant's late request for hearing on decision # 70117 because the questionnaire response was late. This matter comes before EAB based upon claimant's June 2, 2021 late applications for review of Orders No. 21-UI-166634 and 21-UI-166637.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-166634 and 21-UI-166637. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 21-EAB-0498 and 21-EAB-0499).

**FINDINGS OF FACT:** (1) Order No. 21-UI-166634, mailed to claimant on May 12, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-166634 at 2. Order No. 21-UI-166634 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than June 1, 2021."

(2) Order No. 21-UI-166637, mailed to claimant on May 12, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-166637 at 2. Order No. 21-UI-166637 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than June 1, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late applications for review of Orders No. 21-UI-166634 and 21-UI-166637 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-166634 and 21-UI-166637 were due by June 1, 2021. Because claimant did not file their applications for review until June 2, 2021, the applications for review were late. Claimant provided a written statement with the applications for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review, and claimant's late applications for review are dismissed.

**DECISION:** The applications for review filed June 2, 2021 are dismissed. Orders No. 21-UI-166634 and 21-UI-166637 remain undisturbed.
