2021-EAB-0503

Order No. 21-UI-168374 Affirmed – benefits denied weeks 46-20 through 53-20

Order No. 21-UI-168378 Affirmed – benefits denied weeks 01-21 through 08-21

Order No. 21-UI-168373 Affirmed – benefits denied weeks 09-21 through 11-21

PROCEDURAL HISTORY: On April 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks including November 8, 2020 through January 2, 2021 (weeks 46-20 through 53-20) because he made late weekly claims for benefits for those weeks (decision # 82451). Also on April 23, 2021, the Department served notice of an administrative decision concluding that claimant was denied benefits for the weeks including January 3, 2021 through February 27, 2021 (weeks 01-21 through 08-21) because he made late weekly claims for benefits for those weeks (decision # 82916). Also on April 23, 2021, the Department served notice of an administrative decision concluding that claimant was denied benefits for the weeks including February 28, 2021 through March 20, 2021 (weeks 09-21 through 11-21) because he made late weekly claims for benefits for those weeks (decision # 83454).

Claimant filed a timely request for hearing on the three decisions. On June 3, 2021, ALJ Scott conducted a hearing, and on June 9, 2021 issued Order No. 21-UI-168374 affirming decision # 82451, Order No. 21-UI-168378 affirming decision # 82916, and Order No. 21-UI-168373 affirming decision # 83454. On June 17, 2021, claimant filed an application for review of Orders No. 21-UI-168374, 21-UI-168378, and 21-UI-168373 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-168374, 21-UI-168378, and 21-UI-168373. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0503, 2021-EAB-0505, and 2021-EAB-0504).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-168374, 21-UI-168378, and 21-UI-168373 are affirmed.
