

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0506**

*Late Application for Review Dismissed Without Prejudice*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On July 22, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 5, 2020 (decision # 104740). Claimant filed a timely request for hearing. On August 19, 2020, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for August 28, 2020 at 9:30 a.m. On August 28, 2020, claimant failed to appear at the hearing, and ALJ Murdock issued Order No. 20-UI-153469, dismissing the hearing request due to claimant's failure to appear. On September 17, 2020, Order No. 20-UI-153469 became final without claimant having filed a timely request to reopen the hearing or an application for review of Order No. 20-UI-153469 with the Employment Appeals Board (EAB). On February 11, 2021, claimant filed a late request to reopen the August 28, 2020 hearing. ALJ Kangas considered claimant's request, and on April 8, 2021 issued Order No. 21-UI-164396, denying claimant's request to reopen the hearing as late without a showing of good cause. On April 12, 2021, claimant filed an application for review of Order No. 21-UI-164396 with EAB. On April 20, 2021, EAB issued Appeals Board Decision 2021-EAB-0268, reversing Order No. 21-UI-164396 and remanding the matter for a hearing on whether claimant's late request to reopen the August 28, 2020 hearing should be allowed, and if so, whether the hearing should be reopened. On May 11, 2021, ALJ Murdock conducted the hearing, and on May 18, 2021 issued Order No. 21-UI-167027, denying claimant's request to reopen the August 28, 2020 hearing. On June 7, 2021, Order No. 21-UI-167027 became final without claimant having filed an application for review with EAB. On June 21, 2021, claimant filed a late application for review with EAB. This matter comes before EAB based upon claimant's June 21, 2021 application for review of Order No. 21-UI-167027

**CONCLUSIONS AND REASONS:** The application for review should be dismissed without prejudice.

On June 21, 2021, the appellant filed an application for review of Order No. 21-UI-167027 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than June 7, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is July 8, 2021, making the deadline July 28, 2021 to file the request for reconsideration, *and*
2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they or their families were ill or quarantined around the deadline, the nature, extent and duration of any such illness, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx>, *or*

**DECISION:** The application for review filed June 21, 2021 is dismissed without prejudice. Order No. 21-UI-167027 remains undisturbed.
