EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0514

Affirmed Ineligible Weeks 01-21 through 11-21 Eligible Week 12-21

PROCEDURAL HISTORY: On January 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work and therefore not eligible for benefits from January 3, 2021¹ through January 16, 2021 (weeks 01-21 through 02-21), and until the reason for the denial had ended (decision # 130446). Claimant filed a timely request for hearing. On June 7, 2021, ALJ Monroe conducted a hearing, and on June 15, 2021 issued Order No. 21-UI-168724, modifying decision # 130446 by concluding that claimant was not available for work and not eligible for benefits from January 3, 2021 through March 20, 2021 (weeks 01-21 through 11-21), but was available for work and eligible for benefits from March 21, 2021 through March 27, 2021 (week 12-21). On June 23, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-168724 is affirmed.
