EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0515

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 13, 2020 (decision # 123444). Claimant filed a timely request for hearing. On February 22, 2021, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for March 3, 2021 at 8:15 a.m. On March 3, 2021, claimant failed to appear at the hearing, and ALJ Scott issued Order No. 21-UI-161953, dismissing claimant's request for hearing due to her failure to appear. On March 19, 2021, claimant filed a timely request to reopen the March 3, 2021 hearing. ALJ Kangas considered claimant's request and on June 2, 2021, issued Order No. 21-UI-167918, denying claimant's request to reopen. On June 22, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). EAB considered only information received into the record when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-167918 is affirmed.
