

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0535

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 16, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was paid unemployment insurance benefits and Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled and assessing an overpayment of \$3,155 (decision # 110810). Claimant filed a timely request for hearing. On June 9, 2021, ALJ Frank conducted a hearing, and on June 11, 2021 issued Order No. 21-UI-168550, affirming decision # 110810. On July 1, 2021, Order No. 21-UI-168550 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On July 2, 2021, claimant filed a late application for review of Order No. 21-UI-168550 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-168550, mailed to claimant on June 11, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-168550 at 6. Order No. 21-UI-168550 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before July 1, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-168550 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-168550 was due July 1, 2021. Because claimant did not file their application for review until July 2, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the July 1, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 2, 2021 is dismissed. Order No. 21-UI-168550 remains undisturbed.
