

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0555

Reversed & Remanded

PROCEDURAL HISTORY: On April 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 123225). The employer filed a timely request for hearing. On June 7, 2021, ALJ Frank conducted a hearing and continued the hearing to June 18, 2021. On June 18, 2021, ALJ L. Lee conducted the continued hearing, and on June 22, 2021 issued Order No. 21-UI-169162, concluding that the employer discharged claimant, but not for misconduct and claimant and was not disqualified from receiving benefits based on the work separation. On July 12, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: (1) On July 14, 2021, EAB requested that the Office of Administrative Hearings (OAH) forward the record in this case to EAB for use in reviewing Order No. 21-UI-169162. The record EAB received from OAH on July 14, 2021 did not contain an employer video or videos from a thumb drive, the content of which was received into the record as part of Exhibit 2, and audio files of a recorded conversation that were offered by the employer, but excluded from the record by the ALJ. June 18, 2021 Transcript at 115-116 and 143-145; Order No. 21-UI-169162 at 1.

CONCLUSIONS AND REASONS: This matter is set aside as unsupported by a complete record, and remanded to OAH for such other and further proceedings as may be necessary to complete the record.

ORS 657.275 provides that EAB shall review the record of the case and promptly affirm, modify, or set aside the order of the ALJ if the Director of the Department, or any interested party, files a timely application for review. On July 14, 2021, EAB notified OAH that an application for review of Order No. 21-UI-169162 had been filed and requested the record in this case. Thirty-two days after the employer filed their application for review on July 12, 2021, the record is not yet complete, and it appears that further proceedings are or may be necessary before the complete record can be provided. Order No. 21-UI-169162 must therefore be reversed as unsupported by a complete record, and the case remanded for such other and further proceedings as may be necessary to complete the record.

DECISION: Order No. 21-UI-169162 is set aside, and this matter remanded for further proceedings consistent with this order.
