

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0563

Affirmed
Overpayment Assessed

PROCEDURAL HISTORY: On January 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was paid unemployment insurance benefits to which she was not entitled, and assessing an overpayment of \$1,435 in regular benefits and \$4,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits which she was required to repay to the Department (decision # 93718). Claimant filed a timely request for hearing. On July 1, 2021, ALJ Janzen conducted a hearing, and on July 6, 2021 issued Order No. 21-UI-169824, modifying decision # 93718 by concluding that claimant was overpaid \$1,435 in Pandemic Unemployment Assistance (PUA) benefits and \$4,200 in FPUC benefits which she was required to repay to the Department. On July 12, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-169824 is affirmed.
