EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0572

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 2, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 55412). On April 22, 2020, decision # 55412 became final without the employer having filed a request for hearing. On July 30, 2020, the employer filed a late request for hearing on decision # 55412. On June 30, 2021, ALJ Amesbury conducted a hearing at which claimant failed to appear, and on July 1, 2021 issued Order No. 21-UI-169730, dismissing the employer's request for hearing as late without a showing of good cause and leaving decision # 55412 undisturbed. On July 14, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the employer's written argument when reaching this decision.

In their written argument, the employer's representative, a third-party administrator, asserted that their "claims specialist appealed the only decision [they] received on the due date," and that due to increased workload resulting from the COVID-19 pandemic, "trying to get appeals out early to an unknow[n] Oregon Statutes [*sic*] 471-040-0010(3) was not on our minds during the pandemic." Employer's Written Argument at 1. The employer appears to be referring here to the fact that while they did not receive decision # 55412 in the ordinary course of mail, they did timely receive the Department's July 10, 2020 notice that their request for relief of charges had been denied and that they filed a timely appeal on that document. The statement also seems to reference the representative's suggestion at hearing that the claims specialist who filed the July 30, 2020 request for hearing misunderstood the distinction between the underlying administrative decision and the subsequent relief-of-charges decision. Transcript at 19–20.

However, this stands in contrast with the representative's confirmation at hearing that the claims representative "assumed" that the request for hearing filed on July 30, 2020 would be construed as an appeal of both the underlying administrative decision and the subsequent relief-of-charges denial, and

the representative's assertion that "the claim specialist knew that [they] did not get the April 2020 [administrative decision]." Transcript at 22. When viewed as a whole, the scenario which appears to have occurred is that the employer's representative became aware of the existence of decision # 55412, including its outcome and the date on which it was issued, at the time that they received the relief-of-charges denial in July 2020. As an agent who specialized in the handling of unemployment insurance claims, the representative either knew or had reason to know that the timely appeal deadline for decision # 55412 was 20 days from its issuance. The order under review therefore correctly concluded that the "employer's awareness of the administrative decision (including the effect of that decision) started a seven-day window within which [the] employer could appeal" decision # 55412, which "closed on July 24, 2020." Order No. 21-UI-169730 at 4. Because the employer did not file their request for hearing on decision # 55412 until July 30, 2020, they did not have good cause to file the late request for hearing.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-169730 is affirmed.
