

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0583**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On September 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective July 14, 2019 (decision # 121329). On October 15, 2019, decision # 121329 became final without claimant having filed a request for hearing. On December 23, 2020, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 30, 2020 issued Order No. 20-UI-158366, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 13, 2021. On January 7, 2021, claimant filed a timely response to the appellant questionnaire. On February 1, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-158366 was vacated and that a hearing would be scheduled. On June 24, 2021, OAH mailed notice of a hearing scheduled for July 7, 2021 to consider claimant's late request for hearing and, if allowed, the merits of decision # 121329. On July 7, 2021, ALJ Mott conducted a hearing, and on July 9, 2021 issued Order No. 21-UI-170052, re-dismissing claimant's late request for hearing as without good cause, leaving decision # 121329 undisturbed. On July 14, 2021, claimant filed a timely application for review of Order No. 21-UI-170052 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-170052 is affirmed.
