EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0590

Late Application for Review Allowed Affirmed - No Disqualification

PROCEDURAL HISTORY: On April 8, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective March 14, 2021 (decision # 103747). Claimant filed a timely request for hearing. On June 17, 2021, ALJ Kaneshiro conducted a hearing, and on June 21, 2021 issued Order No. 21-UI-169086, reversing decision # 103747 by concluding that claimant voluntarily left work with good cause, which did not disqualify claimant from receiving benefits. On July 12, 2021, Order No. 21-UI-169086 became final without the employer having filed a timely application for review with the Employment Appeals Board (EAB). On July 23, 2021, the employer filed a late application for review of Order No. 21-UI-169086 with EAB.

LATE APPLICATION FOR REVIEW: An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

In their late application for review, the employer stated that they did not receive Order No. 21-UI-169086 until July 22, 2021 and they filed their late application for review with EAB on July 23, 2021. The employer's failure to receive Order No. 21-UI-169086 until July 22, 2021 constituted a circumstance beyond the employer's reasonable control that prevented timely filing. Because the employer filed their late application for review the day after they received Order No. 21-UI-169086, which is a reasonable time under OAR 471-041-0070(2)(b), the employer's late application for review is allowed. **WRITTEN ARGUMENT:** The employer's written argument contained new information from claimant's supervisor that was not part of the hearing record. EAB regards the employer's written argument, in part, as a request that EAB consider additional evidence, which request is hereby denied. The employer did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information from claimant's supervisor during the hearing. The new information was also not material to EAB's determination because, even if considered, it was insufficient to overcome the weight appropriately given to claimant's first-hand hearing testimony of his conversation with the Human Resources representative on March 1, 2021. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-169086 is affirmed.
