# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0598

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On February 10, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA), concluding that claimant was not eligible to receive PUA benefits effective May 3, 2020. On March 2, 2021, the February 10, 2021 administrative decision became final without claimant having filed a request for hearing. On March 6, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 5, 2021 issued Order No. 21-UI-164157, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 19, 2021. On April 26, 2021, Order No. 21-UI-164157 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On June 7, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-164157 with EAB. On July 20, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 21-UI-164157 remained in effect. This matter comes before EAB based upon claimant's June 7, 2021 application for review of Order No. 21-UI-164157.

**EVIDENTIARY MATTER:** On June 29, 2021, claimant filed an additional appellant questionnaire response. The response was on a form which appears to have been originally issued to a different claimant, but nevertheless contained new information which purported to explain why claimant filed their hearing request late. However, because the new information is not material to EAB's determination of whether claimant had good cause to file the late application for review, under OAR 471-041-0090(1)(b)(A) (May 13, 2019), EAB has not considered the new information when reaching this decision.

**FINDING OF FACT:** (1) Order No. 21-UI-164157, mailed to claimant on April 5, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164157 at 2. Order No. 21-UI-164157 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 26, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-164157 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164157 was due by April 26, 2021. Because claimant did not file their application for review until June 7, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed June 7, 2021 is dismissed. Order No. 21-UI-164157 remains undisturbed.
