EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0599

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct for failure to maintain a license necessary to the performance of their occupation and was disqualified from receiving unemployment insurance benefits effective November 10, 2019 (decision # 73058). On December 26, 2019, decision # 73058 became final without claimant having filed a request for hearing. On February 12, 2021, claimant filed a late request for hearing on decision # 73058.

On March 4, 2021, ALJ Kangas issued Order No. 21-UI-162139, dismissing claimant's request for hearing on decision # 73058 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 18, 2021. On March 24, 2021, Order No. 21-UI-162139 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB).

On June 25, 2021 claimant filed a late response to the appellant questionnaire and a late application for review with EAB.¹ On July 20, 2021, ALJ Kangas mailed a letter to claimant stating that because their response to the appellant questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order regarding claimant's late request for hearing and that Order No. 21-UI-162139 remained in effect. This matter comes before EAB based upon claimant's June 25, 2021 late application for review of Order No. 21-UI-162139.

FINDING OF FACT: (1) Order No. 21-UI-162139, mailed to claimant on March 4, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-162139 at 2.

¹ Claimant filed their application for review by mail. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The envelope in which claimant mailed their application for review had a postmark date that was not clear. Where information necessary to determine a filing date is unclear, "the filing date is the date that EAB determines to be the most probable date of filing." OAR 471-041-0065(2). EAB deems the most probable date of filing to be June 25, 2021.

Order No. 21-UI-162139 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than March 24, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-162139 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-162139 was due by March 24, 2021. Because claimant did not file their application for review until June 25, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed June 25, 2021 is dismissed. Order No. 21-UI-162139 remains undisturbed.
