EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0606

Application for Review Dismissed No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective March 8, 2020 (decision #82833). On December 14, 2020, decision #82833 became final without claimant having filed a request for hearing. On March 17, 2021, claimant filed a late request for hearing. On April 14, 2021, ALJ Kangas issued Order No. 21-UI-164819, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 28, 2021. On May 4, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-164819 with the Employment Appeals Board (EAB). On May 17, 2021, ALJ Kangas mailed a letter to claimant stating that because claimant's response was late, the Office of Administrative Hearings (OAH) would not consider the response or issue another order regarding the matter, and Order No. 21-UI-164819 remained in effect. EAB reviewed Order No. 21-UI-164819 based upon claimant's May 4, 2021 application for review.

On June 8, 2021, EAB issued Appeals Board Decision 2021-EAB-0419, setting aside Order No. 21-UI-164819 and remanding the matter for a hearing on whether claimant's late request for hearing on decision #82833 should be allowed and, if so, the merits of that decision. On June 10, 2021, the Office of Administrative Hearings (OAH) mailed notice of hearing on June 30, 2021 to consider claimant's late request for hearing and if allowed, the merits of decision #82833. On June 30, 2021, ALJ Janzen conducted a hearing, and on July 1, 2021 issued Order No. 21-UI-169662, allowing claimant's late request for hearing and concluding that the employer discharged claimant, but not for misconduct, which did not disqualify claimant from receiving unemployment insurance benefits. On July 21, 2021, claimant filed an application for review of Order No. 21-UI-169662 with EAB.

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 21-UI-169662 presents no justiciable controversy and is dismissed.

On July 21, 2021, the Employment Appeals Board (EAB) received from claimant an application for review of an order that allowed the appellant benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 21-UI-169662 is dismissed, and Order No. 21-UI-169662 remains undisturbed.

DECISION: The application for review filed by claimant on July 21, 2021 is dismissed. Order No. 21-UI-169662 remains undisturbed.
