

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0611

Reversed & Remanded

PROCEDURAL HISTORY: On March 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective May 17, 2020 (decision # 64254). Claimant filed a timely request for hearing. On July 13, 2021, ALJ Micheletti conducted a hearing, and on July 21, 2021 issued Order No. 21-UI-170771, reversing decision # 64254 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits based on the work separation. On July 23, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: (1) On July 30, 2021, EAB requested that the Office of Administrative Hearings (OAH) forward the record in this case to EAB for use in reviewing Order No. 21-UI-170771. The record EAB received from OAH on August 2, 2021 did not contain the employer documents that the ALJ received into the record as Exhibits 101 and 102 in a format reviewable by EAB. Order No. 21-UI-170771 at 1.

CONCLUSIONS AND REASONS: Order No. 21-UI-170771 is set aside as unsupported by a complete record and remanded to OAH for such other and further proceedings as may be necessary to complete the record.

ORS 657.275 provides that EAB shall review the record of the case and promptly affirm, modify, or set aside the order of the ALJ if the Director of the Department or any interested party files a timely application for review. On July 30, 2021, EAB notified OAH that an application for review of Order No. 21-UI-170771 had been filed and requested the record in this case. Thirty-three days after the employer filed their application for review on July 23, 2021, the record is not yet complete, and it appears that further proceedings are or may be necessary before the complete record can be provided. Order No. Order No. 21-UI-170771 must therefore be reversed as unsupported by a complete record, and the case remanded for such other and further proceedings as may be necessary to complete the record.

DECISION: Order No. 21-UI-170771 is set aside, and this matter remanded for further proceedings consistent with this order.
