EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0614

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective September 20, 2020 (decision # 165850). On January 27, 2021, decision # 165850 became final without claimant having filed a request for hearing. On March 30, 2021, claimant filed a late request for hearing on decision # 165850.

ALJ Kangas considered claimant's request, and on April 26, 2021 issued Order No. 21-UI-165563, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 10, 2021. On May 11, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-165563 with the Employment Appeals Board (EAB). On July 28, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's May 11, 2021 application for review of Order No. 21-UI-165563.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 21-UI-165563 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 165850 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on decision # 165850 was January 7, 2021. Claimant filed their request for hearing on March 30, 2021. Therefore, the request for hearing was late. In their appellant questionnaire response, claimant indicated that they were unsure of when they received the administrative decision, and that they "had to call and find out [and] never got a letter." EAB Exhibit 1 at 1. This suggests that claimant may not have ever received a copy of decision # 165850. However, it is not clear from claimant's response whether they actually received the administrative decision, if so, when, if not, when and by what means they learned of the administrative decision, and what prompted claimant to file their request for hearing when they did. On remand, the record should be developed to answer those questions. To the extent that the record on remand shows that claimant's late request for hearing was due to circumstances beyond their control or an excusable mistake, the ALJ should also inquire as to whether claimant filed their request for hearing within a reasonable time after the circumstances that prevented a timely filing ceased to exist.

Additionally, claimant indicated in their appellant questionnaire response that they "did" file their request for hearing prior to the timely filing deadline. EAB Exhibit 1 at 2. The record contains no further indication that claimant filed a request for hearing prior to March 30, 2021, and claimant did not offer additional explanation. On remand, the ALJ should inquire as to what efforts, if any, claimant made to file a request for hearing by January 27, 2021 and, if so, whether those efforts constituted timely requests for hearing.

Because further development of the record is necessary for a determination of whether claimant's late request for hearing should be allowed, Order No. 21-UI-165563 is reversed, and this matter is remanded and for a hearing on that issue and, if appropriate, the merits of decision # 165850.

DECISION: Order No. 21-UI-165563 is set aside, and this matter remanded for further proceedings consistent with this order.
