EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0619

Affirmed
Request to Cancel Claim Denied

PROCEDURAL HISTORY: On June 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant's request to cancel their claim was denied (decision # 121347). Claimant filed a timely request for hearing. On July 8, 2021, ALJ Janzen conducted a hearing, and on July 9, 2021 issued Order No. 21-UI-170063, affirming decision # 121347. On July 29, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) On April 29, 2021, claimant filed an initial claim for unemployment insurance benefits.

- (2) Claimant claimed benefits for each of the weeks including April 18, 2021 through July 3, 2021 (weeks 16-21 through 26-21). The Department paid claimant benefits for each of those weeks, first by paper check and thereafter by loading benefit payments on a ReliaCard that had been issued to claimant.
- (3) On or about May 14, 2021, claimant cashed the paper check the Department issued to him. Thereafter, claimant used his ReliaCard to make purchases or payments with the benefit payments he had received.
- (4) On June 8, 2021, claimant requested in writing online that the Department cancel his unemployment insurance claim.

CONCLUSIONS AND REASONS: Claimant's request to cancel his claim for benefits is denied.

ORS 657.266(4) provides that an initial or amended determination of eligibility and amount of benefits may be canceled by the claimant at any time even though final, providing no disqualification has been assessed, no appeal of a disqualification or denial has been requested by the claimant nor benefits paid on such claim. OAR 471-030-0095 (January 11, 2018) states:

(1) An initial or amended determination may be canceled at any time provided the requirements of ORS 657.266(4) are met.

- (2) Requests for cancellation may be taken by phone or in writing. Any written request must be signed by the claimant or by an authorized agent of the claimant.
- (3) Cancellation will be denied if benefits have been paid. Benefits have been paid if the claimant negotiates a benefit check or if the claimant's account in a bank or similar financial institution has been credited with one or more benefit payments.

Claimant did not meet the requirements for having his initial claim for benefits cancelled. There was no dispute that the Department paid claimant benefits for each of the weeks claimed and that claimant cashed the paper check he received and used the benefit payments credited to his Reliacard to make purchases or payments. Accordingly, under ORS 657.266(4) and OAR 471-030-0095, because benefits were paid to claimant, his request to cancel his claim must be denied.

DECISION: Order No. 21-UI-170063 is affirmed.
