# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0622

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 6, 2020 (decision # 112642). Claimant filed a timely request for hearing. On March 16, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 30, 2021 at 1:30 p.m. On March 30, 2021, claimant failed to appear at the hearing, and on March 31, 2021 ALJ Hoppe issued Order No. 21-UI-163775 dismissing claimant's hearing request for failure to appear. On April 5, 2021, claimant filed a timely request to reopen the March 30, 2021 hearing. ALJ Kangas considered claimant's request, and on July 6, 2021 issued Order No. 21-UI-169828, denying the request and leaving Order No. 21-UI-163775 undisturbed. On July 26, 2021, Order No. 21-UI-169828 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On July 29, 2021, claimant filed a late application for review of Order No. 21-UI-169828 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-169828, mailed to claimant on July 6, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-169828 at 3. Order No. 21-UI-169828 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 26, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-169828 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing

ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filling. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-169828 was due by July 26, 2021. Because claimant did not file their application for review until July 29, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 29, 2021 is dismissed. Order No. 21-UI-169828 remains undisturbed.
