# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0641

#### Late Application for Review Dismissed Without Prejudice

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On February 11, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective January 24, 2021 (decision # 113815). On March 3, 2021, decision # 113815 became final without claimant having filed a request for hearing. On March 17, 2021, claimant filed a late request for hearing on decision # 113815. ALJ Kangas reviewed claimant's hearing request, and on April 13, 2021, issued Order No. 21-UI-164654, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 27, 2021. On May 3, 2021, Order No. 21-UI-164654 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On August 5, 2021, claimant filed a late application for review of Order No. 21-UI-164654 with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On August 5, 2021, the appellant filed an application for review of Order No. 21-UI-164654 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than May 3, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is August 27, 2021, making the deadline September 16, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, if the appellant believes they filed an application for review before the deadline by filing submissions on previous occasions but with incorrect case numbers the appellant should state the dates she filed those submissions and what information she included in those submissions, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or

**DECISION:** The application for review filed August 5, 2021 is dismissed without prejudice. Order No. 21-UI-164654 remains undisturbed.
