

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0646

Affirmed

Ineligible Weeks 52-20 through 19-21, Weeks 23-21 through 24-21, and Week 26-21

PROCEDURAL HISTORY: On May 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from December 20, 2020 through April 24, 2021 (weeks 52-20 through 16-21) and therefore was not eligible to receive Pandemic Unemployment Assistance (PUA) benefits for those weeks (decision # 93023). Claimant filed a timely request for hearing. On July 1, 2021, ALJ Scott conducted a hearing at which claimant appeared and requested the hearing be rescheduled. The Department's witness did not object to claimant's request and ALJ Scott rescheduled the hearing for July 30, 2021.

On July 1, 2021, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 30, 2021 at 10:45 a.m. On July 30, 2021, ALJ Scott conducted a hearing at which claimant failed to appear, and on August 3, 2021 issued Order No. 21-UI-171684, modifying decision # 93023 by concluding that claimant was not available for work during weeks 52-20 through 16-from December 20, 2020 through May 15, 2021 (weeks 52-20 through 19-21), June 6, 2021 through June 19, 2021 (weeks 23-21 through 24-21), and June 27, 2021 through July 3, 2021 (week 26-21), and therefore was not eligible to receive benefits for those weeks. On August 6, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-171684 is affirmed.
