

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0649

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective May 9, 2021 (decision # 80825). Claimant filed a timely request for hearing. On July 19, 2021, ALJ Amesbury conducted a hearing, and on July 20, 2021 issued Order No. 21-UI-170721, modifying decision # 80825 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective May 2, 2021. On August 9, 2021, Order No. 21-UI-170721 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On August 11, 2021, claimant filed a late application for review of Order No. 21-UI-170721.

FINDING OF FACT: (1) Order No. 21-UI-170721, mailed to claimant on July 20, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-170721 at 4. Order No. 21-UI-170721 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before August 9, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-170721 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-170721 was due by August 9, 2021. Because claimant did not file their application for review until August 11, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed August 11, 2021 is dismissed. Order No. 21-UI-170721 remains undisturbed.
