EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0649-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective May 9, 2021 (decision # 80825). Claimant filed a timely request for hearing. On July 19, 2021, ALJ Amesbury conducted a hearing, and on July 20, 2021 issued Order No. 21-UI-170721, modifying decision # 80825 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective May 2, 2021. On August 9, 2021, Order No. 21-UI-170721 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 11, 2021, claimant filed a late application for review of Order No. 21-UI-170721 with EAB. On September 3, 2021, EAB issued EAB Decision 2021-EAB-0649, dismissing claimant's late application for review, and leaving Order No. 21-UI-170721 undisturbed. On November 26, 2021, claimant filed a late request for reconsideration of EAB Decision 2021-EAB-0649 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration of EAB Decision 2021-EAB-0649 is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB mailed EAB Decision 2021-EAB-0649 on September 3, 2021. Under OAR 471-041-0145(2), the request for reconsideration was due by September 23, 2021. Claimant's request for reconsideration was filed on November 26, 2021, more than two months after EAB Decision 2021-EAB-0649 was mailed,

and did not include a statement that a copy of the request for reconsideration was provided to the other parties. OAR 471-041-0145(2) contains no exception to the requirements that a request for reconsideration must be filed on or before the 20th day after the decision sought to be reconsidered was mailed and include a statement that a copy of the request for reconsideration was provided to the other parties. For these reasons, claimant's request for reconsideration is therefore dismissed.

DECISION: The request for reconsideration filed on November 26, 2021 is dismissed. Order No. 21-UI-170721 remains undisturbed.
