

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0656**

*Affirmed ~ Late Request for Hearing Dismissed*  
*Affirmed ~ Overpayment Assessed*

**PROCEDURAL HISTORY:** On July 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work beginning March 29, 2020 (week 14-20) and was therefore not eligible to receive unemployment insurance benefits for that week and until the reason for the denial had ended (decision # 64311). On August 18, 2020, decision # 64311 became final without claimant having filed a request for hearing. On November 9, 2020, the Department served notice of an administrative decision, based in part on decision # 64311, concluding that claimant received benefits to which they were not entitled and assessing an overpayment of \$2,184 in regular unemployment insurance benefits and \$4,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 132804). On November 20, 2020, claimant filed a late request for hearing on decision # 64311 and a timely request for hearing on decision # 132804.

On July 22, 2021, ALJ Monroe conducted two hearings, and on July 30, 2021 issued Order No. 21-UI-171531, dismissing the request for hearing on decision # 64311 as late without good cause, and Order No. 21-UI-171534 affirming decision # 132804. On August 10, 2021, claimant filed applications for review of Orders No. 21-UI-171531 and 21-UI-171534 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-171531 and 21-UI-171534. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0656 and 2021-EAB-0655).

EAB reviewed the entire hearing record in both cases. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 21-UI-171531 and 21-UI-171534 are affirmed.
