EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0676

Affirmed Disqualification Overpayment and Penalties

PROCEDURAL HISTORY: On November 6, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause, disqualifying claimant from receiving unemployment insurance benefits effective March 1, 2020 (decision # 142422). On November 30, 2020, decision # 142422 became final without claimant having filed a request for hearing. On December 9, 2020, the Department served notice of an administrative decision, based in part on decision # 142422, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$2,165 overpayment of regular benefits, a \$6,000 overpayment of Federal Pandemic Unemployment Compensation (FPUC) and Lost Wage Assistance (LWA) benefits, a \$324.75 monetary penalty, and 14 penalty weeks. On December 11, 2020, claimant filed a late request for hearing on decision #142422 and a timely request for hearing on the December 9, 2020 overpayment decision.

ALJ Kangas considered claimant's late request for hearing on decision #142422, and on December 17, 2020 issued Order No. 20-UI-157829, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 31, 2020. On December 19, 2020, claimant filed a timely response to the appellant questionnaire, and on December 23, 2020 the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 20-UI-157829 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing would be allowed and, if so, the merits of decision # 142422. On December 30, 2020, OAH served notice of a hearing scheduled for January 15, 2021 at 8:15 a.m. to consider whether claimant's late request for hearing on decision #142422 should be allowed and, if so, the merits of that decision. On January 15, 2021, claimant failed to appear at the hearing, and ALJ M. Davis issued Order No. 21-UI-159263, dismissing the hearing request due to claimant's failure to appear. On January 24, 2021, claimant filed a request to reopen the January 15, 2021 hearing.

On July 23, 2021, OAH served notice of a consolidated hearing scheduled for August 10, 2021 at 9:30 a.m. to consider the merits of the December 9, 2020 overpayment decision and claimant's request to reopen the hearing on decision # 142422 and, if allowed, claimant's late request for hearing of decision

142422 and, if allowed, the merits of decision # 142422. On August 10, 2021, ALJ Murdock conducted a hearing, and on August 17, 2021 issued Order No. 21-UI-172671, allowing claimant's request to reopen the January 15, 2021 hearing and late request for hearing on decision # 142422, and affirming that decision. On August 18, 2021, ALJ Murdock issued Order No. 21-UI-172871, affirming the December 9, 2020 overpayment decision. On August 20, 2021, claimant filed applications for review of Orders No. 21-UI-172671 and 21-UI-172871 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-172671 and 21-UI-172871. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0676 and 2021-EAB-0677).

EAB reviewed the entire combined hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-172671 and 21-UI-172871 are affirmed.
