EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0684-R

Request for Reconsideration Allowed EAB Decision 2021-EAB-0684 Adhered to on Reconsideration Affirmed ~ Disqualification

PROCEDURAL HISTORY: On July 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 18, 2021 (decision # 162649). Claimant filed a timely request for hearing. On August 13, 2021, ALJ Wardlow conducted a hearing, at which the employer failed to appear, and on August 19, 2021 issued Order No. 21-UI-172971, affirming decision # 162649 by concluding that claimant was discharged for misconduct and was disqualified from receiving benefits effective April 18, 2021. The matter came before EAB based upon claimant's August 23, 2021 application for review of Order No. 21-UI-172971. On September 24, 2021, EAB issued EAB Decision 2021-EAB-0684, affirming Order No. 21-UI-172971, and served the decision on claimant. On October 11, 2021, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0684 is adhered to on reconsideration.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2021-EAB-0684 on September 24, 2021. Claimant filed their request for reconsideration on October 11, 2021, less than 20 days after EAB Decision 2021-EAB-0684 was mailed. Claimant's request for reconsideration therefore was timely, and is allowed.

EAB Decision 2021-EAB-0684 concluded that the employer discharged claimant for misconduct connected with work and claimant was disqualified from receiving unemployment insurance benefits based on the work separation, effective April 18, 2021. EAB Decision 2021-EAB-0684 at 2-4. Here, claimant's statement included with their request for reconsideration did not assert or show that EAB Decision 2021-EAB-0684 contained an error of material fact or law, or any inconsistency with Employment Department rule, officially stated Employment Department position, or prior Employment Department practice. Because claimant has not shown that EAB made an error of the type described in OAR 471-041-0145(1), EAB Decision 2021-EAB-0684 is adhered to on reconsideration.

DECISION: Claimant's request for reconsideration is allowed. On reconsideration, EAB Decision 2021-EAB-0684 is adhered to as clarified herein.
