

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0687**

*Affirmed  
Ineligible for Pandemic Unemployment Assistance*

**PROCEDURAL HISTORY:** On June 14, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On June 16, 2021, claimant filed a timely request for hearing. On August 11, 2021, ALJ Frank conducted a hearing, and on August 19, 2021 issued Order No. 21-UI-172956, affirming the June 14, 2021 administrative decision. On August 24, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** In his August 24, 2021 written argument, claimant asserts that the ALJ erred in excluding claimant's documentary evidence at the hearing. However, OAR 471-040-0025(5) (August 1, 2004) states that irrelevant, immaterial or unduly repetitious evidence shall be excluded, and that erroneous rulings on evidence shall not preclude the ALJ from entering a decision unless shown to have substantially prejudiced the rights of a party. The ALJ was not convinced of the relevance or materiality of claimant's documentary evidence before taking testimony at the hearing, and claimant has not explained their relevance or materiality in his written argument. Therefore, claimant did not establish that the ALJ erred by excluding the documentary evidence. In addition, the ALJ allowed claimant the opportunity to revisit the admissibility of the documentary evidence as the hearing progressed, but claimant did not do so. Thus, even if the ALJ erred in excluding claimant's documentary evidence, claimant failed to show the error substantially prejudiced his rights.

The remainder of claimant's August 24, 2021 written argument, and his August 27, 2021, September 1, 2021, September 3, 2021, and September 16, 2021 written arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's arguments to the extent they were based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-172956 is affirmed.
