EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0687-R

*Request for Reconsideration Allowed
EAB Decision 2021-EAB-0687 Adhered to on Reconsideration
Ineligible for Pandemic Unemployment Assistance*

PROCEDURAL HISTORY: On June 14, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On June 16, 2021, claimant filed a timely request for hearing. On August 11, 2021, ALJ Frank conducted a hearing, and on August 19, 2021 issued Order No. 21-UI-172956, affirming the June 14, 2021 administrative decision. On August 24, 2021, claimant filed an application for review with the Employment Appeals Board (EAB) of Order No. 21-UI-172956. On September 28, 2021, EAB issued EAB Decision 2021-EAB-0687, affirming and adopting Order No. 21-UI-172956. On October 8, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-0687. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0687 is adhered to on reconsideration.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, when applicable, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2021-EAB-0687 on September 28, 2021. Claimant filed their request for reconsideration on October 8, 2021, less than 20 days after EAB Decision 2021-EAB-0687 was mailed. Claimant's request for reconsideration therefore was timely, and is allowed.

Claimant's request for reconsideration did not show that EAB Decision 2021-EAB-0687, which affirmed and adopted Order No. 21-UI-172956 and concluded that claimant was ineligible for Pandemic Unemployment Assistance benefits, contained any error of material fact or law, or was otherwise inconsistent with any Department rule, officially stated Department position or prior Department practices. EAB Decision 2021-EAB-0687 is therefore adhered to on reconsideration.

DECISION: Claimant's request for reconsideration is allowed. On reconsideration EAB Decision 2021-EAB-0687 is adhered to herein.
