

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0692

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 16, 2021, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report concluding that claimant was entitled to a weekly benefit amount of \$433 and a maximum benefit amount of \$11,258. On March 26, 2021, the March 16, 2021 administrative decision became final without claimant having filed a request for hearing. On April 13, 2021, claimant filed a late request for hearing on the March 16, 2021 administrative decision. ALJ Kangas considered claimant's request, and on May 11, 2021 issued Order No. 21-UI-166526, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 25, 2021. On May 14, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire, and on August 24, 2021 issued Order No. 21-UI-173196, canceling Order No. 21-UI-166526, re-dismissing claimant's late request for hearing, and leaving the March 16, 2021 administrative decision undisturbed. On August 27, 2021, claimant filed an application for review of Order No. 21-UI-173196 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-173196 is affirmed.
