

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0705

Order No. 21-UI-171879 Affirmed ~ Late Claim for Benefits Week 21-21 Denied
Order No. 21-UI-171880 Affirmed ~ Late Claims for Benefits Weeks 13-21 through 20-21 Denied

PROCEDURAL HISTORY: On June 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of May 23, 2021 through May 29, 2021 (week 21-21) and therefore was denied benefits for that week (decision # 145949). Also on June 15, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks including March 28, 2021 through May 22, 2021 (weeks 13-21 through 20-21) and therefore was denied benefits for those weeks (decision # 145458). Claimant filed timely requests for hearing on decisions # 145949 and 145458. On August 4, 2021, ALJ Janzen conducted a consolidated hearing on decisions # 145949 and 145458, and on August 5, 2021 issued Orders No. 21-UI-171879 and 21-UI-171880, affirming decisions # 145949 and 145458, respectively. On August 21, 2021, claimant filed applications for review of Orders No. 21-UI-171879 and 21-UI-171880 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-171879 and 21-UI-171880. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0705 and 2021-EAB-0706).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-171879 and 21-UI-171880 are affirmed.
