

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0709

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective January 12, 2020 (decision # 125655). Claimant filed a timely request for hearing. On April 15, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 30, 2021 at 9:30 a.m. On April 30, 2021, claimant failed to appear at the hearing, and ALJ Micheletti issued Order No. 21-UI-165983, dismissing the hearing request due to claimant's failure to appear. On May 11, 2021, claimant filed a request to reopen the April 30, 2021 hearing. ALJ Kangas reviewed claimant's request to reopen, and on August 12, 2021, issued Order No. 21-UI-172472 denying the request and leaving Order No. 21-UI-165983 undisturbed. On August 29, 2021, claimant filed an application for review of Order No. 21-UI-172472 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the record with their request to reopen as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into the record when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-172472 is affirmed.
