## EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0732

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work or available for work during the weeks including February 7, 2021 through February 20, 2021 (weeks 06-21 and 07-21) and was therefore ineligible to receive unemployment insurance benefits for those weeks and until the reason for the denial ended (decision # 54019). On May 13, 2021, decision # 54019 became final without claimant having filed a request for hearing. On June 4, 2021, claimant filed a late request for hearing on decision # 54019. ALJ Kangas considered claimant's request, and on August 11, 2021 issued Order No. 21-UI-172352, dismissing the request as untimely without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 25, 2021. On August 31, 2021, Order No. 21-UI-172352 became final without claimant having responded to the appellate questionnaire or filed an application for review of Order No. 21-UI-172352 with the Employment Appeals Board (EAB). On September 1, 2021, claimant filed a late application for review of Order No. 21-UI-172352 and a late response to the appellant questionnaire with EAB. This matter comes before EAB based upon claimant's September 1, 2021 late application for review of Order No. 21-UI-172352.

**FINDING OF FACT:** (1) Order No. 21-UI-172352, mailed to claimant on August 11, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-172352 at 2. Order No. 21-UI-172352 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than August 31, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-172352 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-172352 was due by August 31, 2021. Because claimant did not file their application for review until September 1, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed September 1, 2021 is dismissed. Order No. 21-UI-172352 remains undisturbed.
